Why should I study this course?

The Pearson BTEC Level 3 National Extended Certificate in Health and Social Care aims to provide an introduction to the sector. It is for learners who are interested in learning about the health and social care sector as part of a balanced study programme. It is equivalent in size to one A Level. The qualification supports access to a range of higher education courses possibly, but not exclusively, in health and social care, if taken alongside further Level 3 qualifications. The qualification typically makes up one—third of a study programme.

Who is suitable to study this course?

The qualification supports access to a range of higher education courses possibly, but not exclusively, in health and social care, if taken alongside further Level 3 qualifications. The qualification typically makes up one—third of a study programme.

This qualification is generally taken alongside other qualifications as part of a 2-year programme of learning. This will enable learners to progress to a degree programme chosen from a range of programmes in the health and social care sector. The qualification is intended to carry UCAS points and is recognised by higher education institutions as contributing to meeting admission requirements to many relevant courses.

It can be taken alongside, for example:

- A Levels in Biology and Psychology, which could lead to a BSc (Hons) in Nursing
- A Levels in English and History, which could lead to a BA (Hons) in Primary Education
- a BTEC National Diploma in Children's Play, Learning and Development, which could lead to a BSc (Hons) in Social Work
- a BTEC National Extended Certificate in Sport, which could lead to a Foundation Degree in Sports Studies and Development.

What GCSE Qualifications Support the Study of this Course?

Level 4 or above in GCSEs in English, Maths and Science would be strongly encouraged as would a Level 2 Pass or better in Level 2 Health and Social Care. GCSE, BTEC or OCR would be acceptable.



What are the Qualification Requirements for this Course?

The mandatory content of the qualification incorporates topics relevant across the health and social care sector:

- Human Lifespan Development
- Working in Health and Social Care
- Meeting Individual Care and Support Needs.

Learners will study one optional unit that covers the biological and sociological topics relevant to the different parts of the sector to support their progression to specialised degree programmes in the sector.

Optional units include:

- Sociological Perspectives
- Psychological Perspectives
- Supporting Individuals with Additional Needs
- Physiological Disorders and their Care.

How is the Course Delivered?

The Extended Certificate in health and Social Care will see 5hours of taught lessons a week with an expectation of the same again in private study. All lessons and materials can be accessed via google Classroom, set up specifically for each group. Students can expect to be taught by 2 teachers per year, covering a unit each.
